Mrs. Van Wert, Mr. McCarthy and Mr. Dinolfo are here today to discuss staffing and bookkeeping in the Town's finance department. (a memo is in a previous meeting minutes).

Mr. Dinolfo is doing the Single Audit, this is done when the town receives a certain amount of funding from Federal monies. In 2015 we received monies from FEMA and for the Airport. We will need another audit for 2016. He must prepare a schedule of expenditures and then Audit the AUD. The Town of Ticonderoga receives a lot of funding from the Federal Government making it a complex and time consuming process.

Mr. McCarthy added that the difficulty is having the people here who were responsible for the draw downs and they are not. The numbers we are working with are from the 2013 AUD and those did not agree with 2014 monies. We are playing catch up and the accounting system that you utilize is one of the most difficult systems out there. You really need another full-time person on your staff. This is much more than what he signed up for.

Mrs. Van Wert also explained that the board did hire a part-time, temporary clerk, but she will be leaving soon. This is very tedious and complicated work identifying the issues and then rectifying the issues.

Mr. McCarthy stated that the worst thing that this Town can do is file late and inaccurate reports that will jeopardize future funding. It would be fiscally prudent to pay a full time employee and it is not him. This town is big enough and complex enough to have a controller. (controller not comptroller).

Discussion was held on the problems that we are facing and where to advertise for such a position.
