The budget is primarily complete – we do need to revisit some Capital Reserves, look at fund balances and schedule some workshops with department heads for equipment. The budget is coming in under the tax cap which is at 2% this year. All non-union personnel will receive a 2% wage increase – union contracts for Water/Sewer/Highway allows for 1% and the Police Department is at 2%. Elected officials will also receive a 2% wage increase for salaries to be as follows:

Councilpersons - \$12,424.00 Supervisor - \$43,483.00 Town Clerk - \$51,619.00 Highway Superintendent - \$65,138.00 Town Justices - \$25,883.00
