Supervisor Giordano opened the Organizational Meeting with the Pledge of Allegiance.

(Councilman Hunsdon explained his vote to oppose)

Councilman Hunsdon does not feel that the Town needs Item #24 on the list; we should be able to negotiate our own contracts. This is costing the Town a lot of money.

Supervisor Giordano does not feel that it is costing the Town a lot of money. He also feels that the unions have someone representing them, so it is in the best interest of the Town to have someone representing it.

Councilman Hunsdon also wondered why he was not appointed as a Police Commission, since he is now chairman of the Public Safety Committee.

Supervisor Giordano feels since he is new to this position and to keep the stability of the Commissioner he would like to have the experience of Councilman Taylor and Commission Lauman. This can be re-evaluated at a later time.

Councilman Taylor explained his opinion for adding Item #46, we had an unfortunate experience a few years ago where a contract was signed before it was put before this board. He does not want to see this happen again, with labor agreements. Once it is signed it is a done deal, the board should have input on labor agreements.

Councilwoman Van Wert questioned why the Monthly Financial Meeting was taken off the schedule.

Supervisor Giordano explained that after discussing the purpose of the Financial Meeting, which originated from the need to expedite certain financial processing, it seems that it is not necessary. Right now we will do away with it and if we need to re-instate it at a later point we will, but for right now we will continue with the single regular Town Board meeting. This meeting had become for than just Financial, we shouldn't continue having conversations for matters that folks should be privy to and we should have the camera rolling for those times. If we need to schedule a special meeting we can.

Councilwoman Van Wert asked who we have Shared Service Agreements with - Lake George Village, Hague, Putnam.

Councilman Taylor mentioned that the Highway Superintendent has expressed interest not to have a Highway Committee.

The Board discussed this and agreed that we will start with a committee and re-evaluate at a later time. It is very helpful to continue with a committee meeting to understand the involvement and happenings of the Highway Department operation and it is to helpful with dealing with the public for them to come in at a scheduled date and time with their questions and/or concerns.

**Resolution #2-2016** brought by Fred Hunsdon, seconded by Chattie Van Wert to authorize the Town Clerk to advertise for the position of alternate Lottery Control Officer with a salary of \$1,500.00 annually and no-benefits. **All in Favor;** Joseph Giordano - Aye, - Fred Hunsdon - Aye, Wayne Taylor - Aye, Dorcey Crammond - Aye, Chattie Van Wert - Aye. **Opposed -** none. **Carried.** 

Councilman Taylor wanted to also mention that the Highway Superintendent has discussed posting for on-call seasonal workers. He has also raised the question of hiring a mechanic.

There were RFP's requested for equipment repair work and we received one response. We are waiting for a release to be drawn up in order to avoid any conflict of interest with the company and the Highway Superintendent. This will need to be reviewed further and discussed with the Attorney.

Highway Superintendent Barnao expressed that he would rather have an in-house mechanic instead of having it all farmed out.

The Board will need to gather more information for further discussion.
